You agree not to reproduce, duplicate, sell, or exploit any portion of our services or content, unless you have written permission by Krista Lyn Vaters Interior Design Studio Inc.

## **AGREEMENT**

By purchasing this eDesign package, you are agreeing to the cost outlined in the description and you understand and agree pay the fee in the pricing ranges as outlined in the package description. In exchange for the fee, the designer shall provide the task and material as outlined and agreed upon in the SCOPE OF WORK detail attached.

As the client, you fully understand and agree when purchasing the eDesign package, you are required to provide the information requested of the space and items within to the designer. Withhold requested information, will result in the designer being unable to provide a design to meet the needs and requirements of the space. Please read the REQUIRED OF ME included in the details of this package. If information required to be provided by client is not provided, therefore resulting in a delay to complete the design more than 14 days after the request, Krista Lyn Vaters Interior Design Studio Inc, reserves the right to request progress payment for work already completed.

## **FEES**

The initial fee of \$125 +tax is due upon purchase of this package and the remainder of the balance due as outlined in the payment schedule listed. This fee is non-refundable and is not transferable and will be applied to the total cost of the package as a payment and is not an added cost.

The total cost, as outlined in the package pricing range, will be determined, and agreed upon in the initial meeting where the scope of work per project is determined. If the scope of work is outside the parameters of this package OR the project space is greater than the square footage outlined, the designer reserve the right to terminate this service and offer the appropriate eDesign package for your project or develop a

custom package to meet the requirement of the scope of work and size of space.

## **ADDITIONAL FEES**

If additional services are requested by client that are not included in or above the SCOPE OF WORK, the designer will submit a cost-of-service proposal based on our hourly rates, by which the client will be required to preapprove prior to the rendering of those services. All accepted approvals via our online studio are legally bound.

## **PAYMENT SCHEDULE**

Our payment schedule is outlined as follows:

- Upon purchase the initial fee of \$125+tax is due.
- Prior to the start of the design process 50% of the total cost is due. The design will not be start until this is paid.
- The final balance is due after the final consultation and before the release of the final project details and material

Failure to comply with these payment terms will result a hold on all services and information until the account is paid to date. Any outstanding invoice past 15 days will be subject to a 2% monthly interest charge until payment due is received and paid in full.

#### **TERMS OF PAYMENT**

Krista Lyn Vaters Interior Design Studio Inc accepts payments for eDesign Packages via our online store by credit card or Interac. If the scope of work was extended to include the purchase of products, as outline in the shopping guide on behalf of the client, payment for ALL PRODUCTS via Credit Card will be subject to an additional 3.9% credit card processing fee. ## **REFUNDS, CANCELLATIONS & TERMINATION**

All deposits are non-refundable. If termination of this agreement is required, notification in writing to the other party will be required. If client terminates, you, as the client, are responsible for any outstanding balance for services rendered to date of termination notice. If Krista Lyn Vaters Interior Design Studio Inc. terminates this agreement, any advanced payments received for services not rendered to date of termination notice will be reimbursed.

We reserve the right, but are not obligated, to limit the sales of our services to any person, geographic region or jurisdiction. We may exercise this right on a case-by-case basis. We reserve the right to limit the quantities of any services that we offer. All descriptions of services or service pricing are subject to change at anytime without notice, at the sole discretion of us. We reserve the right to discontinue any service at any time.

We may, in our sole discretion, limit or cancel quantities purchased per person, per household or per order. ## **PROJECT TIMELINES**
